Board members interviewed Candidate C utilizing a set of interview questions developed by the Recruitment Committee. These questions were used for candidates during their virtual interviews. Candidate C is local to the region so these questions were asked in person. Candidate C has just under three years' experience in a leadership position in a Critical Access Hospital in Nevada. The Board members present discussed their thoughts about the candidate's experience and qualities shared during the interview. The Board will continue on with the Candidates A and B and if they are not successful, the Board will continue the search for an experienced candidate.
